5. Bid shall be opened on 2077-09-26 (2021-01-10), 13:00 PM at the office of Kaligandaki Rural Municipality, Purthihat, Gulmi, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security authorized from the recognized commercial bank of Nepal, amounting to a minimum as mentioned above in table, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the bid security in cash, the cash should be deposited in Deposit Account No. **0860035773700005** Kaligandaki Ga Pa Dharauti Khata at Kuman Bank Limited, Purthihat, Gulmi, and submit the receipt of the deposited amount of cash along with the Bid Document.
